Financing Alternatives: Desert Dunes Water Reclamation Facility Expansion							
SUMMARY RECOMMENDATION:							
Authorize the City Administrator and staff to work with Stifel, Nicolaus, and Company, Inc. (Stifel), bond counsel Greenberg Traurig, and the Water Infrastructure Finance Authority of Arizona (WIFA), in connection with securing financing for the expansion of the Desert Dunes Water Reclamation Facility (DDWRF). (Administration/Finance) (Jay Simonton/Barbara Goodrich).							
STRATEGIC OUTCOME:							
In support of the City Council's vision and the strategic outcome of Safe and Prosperous, staff is recommending the expansion of the DDWRF from the current treatment capacity of 3.3 million gallons per day (mgd) to a new treatment capacity of 6.6 mgd.							
REPORT:							
To finance the Desert Dunes facility expansion, estimated at an amount not to exceed \$85,000,000.00, City staff intends to evaluate two options to fund the construction. In coordination with Stifel and Greenberg Traurig, staff will evaluate the possible sale of revenue bonds on the open bond market and in the alternative, securing a low interest loan from WIFA.							

Approving this motion authorizes the City Administrator and staff to work with WIFA, Stifel, and Greenberg Traurig to evaluate and determine the best financing option for the City. In order to advance the WIFA option, a companion resolution on this agenda authorizes the City Administrator to apply for the WIFA loan. A final decision between the alternatives, along with City staff's analysis and recommendation, will be brought forward by ordinance for City Council approval.
