Authorize the City Administrator to execute a contract for Construction Services for the 3rd Avenue Waterline Replacement, between 4th and 5th Streets, to the lowest responsive and responsible bidder in the amount of \$134,969.65.

REPORT:

This project consists of the installation of approximately 670 feet of PVC waterline ranging in size from 4 inches to 10 inches along 3rd Avenue between 4th and 5th streets. Pavement and hardscape replacement will also be done in select areas where construction occurs.
