TITLE: Repeal and Replace: City of Yuma Emergency Operations Plan					

SUMMARY RECOMMENDATION:

Repeal Resolution R2011-29 related to the City of Yuma Emergency Operations Plan 2011 and adopt the updated City of Yuma Emergency Operations Plan 2018. (Fire Department) (Steve Irr)

REPORT:

Title 26, Chapter 2, Article 1, of the Arizona Revised Statutes requires counties and incorporated cities and towns to establish and provide for emergency management within its jurisdiction in accordance with state emergency plans and programs. To comply with this requirement, the City has established written emergency operations plans. The last plan, City of Yuma Emergency Operations Plan (EOP) 2011, is now more than seven-years old and has been updated. The updated plan is known as the City of Yuma Operations Plan 2018 and the adoption of this resolution repeals the 2011 EOP and replaces it with the 2018 EOP.

Having current, updated emergency operation plans are vital to first responders when assisting the public in the event of a natural disaster, manmade incident, or a local or national emergency. When one of these disasters takes place, the state-approved emergency operations plan guides first responders. The purpose of the EOP is to provide direction and guidance to City governmental departments and supporting agencies to help protect the safety of its citizens, preserve life, protect property, minimize damage and return its community and government to its normal state in the event one of these disasters takes place. It is applicable to all elements of the City government and the private sector engaged in, or acting in support of, emergency operations and provides a starting point in the event the federal government intervenes and/or takes jurisdiction.

Adopting this Resolution repeals R2011-29 (City of Yuma EOP 2011) and adopts the updated City of Yuma EOP 2018.
