SUMMARY RECOMMENDATION:  Adoption of this ordinance as an update to the City Code (Code) on permissible consumer fireworks.  (Fire/Community Risk Reduction) (Steve Irr)					
REPORT: The state statute regarding permissible consumer fireworks was amended less than two years ago, and the Arizona League of Cities has now provided a draft ordinance for jurisdictions to incorporate those changes. The Code regarding permissible consumer fireworks was implemented in 2013, prior to these changes in state statute.					
The main differences between the Code and the proposed amendments include revisions required by state statute regarding signage and limitations on sale/use during certain time frames around Independence Day and New Year's Day.					
These modifications will make Yuma more consistent with most other jurisdictions in Arizona, and would be in conformance with the model ordinance proposed by the Arizona League of Cities.
