Southwest Gas Corporation currently holds an easement dedicated to the Arizona Edison Company Inc. via a							
Grant of Easement dated October 25, 1939, recorded in Book 86 of Deeds, Page 493, Yuma County Records.							
The existing easement is described as Lot 8 of Block 14 of Whites Official Survey of Yuma Townsite, which granted excess area for the gas line easement. The new easement describes a specific alignment with an							
easement width of ten feet, as described in the attached easement, exhibit and maps.							
Southwest Gas Corporation will abandon the existing easement upon recordation of the new easement.
