Grant Award: Staffing Adequate Fire and Emergency Response (SAFER) Grant Award

## SUMMARY RECOMMENDATION:

Authorize the City Administrator to accept and execute the required documents for the U.S. Department of Homeland Security FY 2016 Staffing Adequate Fire and Emergency Response (SAFER) Grant Award No. EMW-2016-FH-00628 in the amount of \$1,457,208.00. (Fire Department) (Fire Chief Steve Irr)

## **REPORT:**

Congress, through the U. S. Department of Homeland Security, has continued to appropriate funds for assistance in providing adequate staffing levels of fire departments throughout the country. The City of Yuma Fire Department applied for a grant in calendar year 2017 and has been notified of an award. This grant allows for the City to partially pay salary and benefits for nine new firefighters. These funds will be expended over the course of three years.

The City seeks authority to accept the grant award in the amount of \$1,457,208.00 from the U.S. Department of Homeland Security, which will assist the City to fund the cost of nine additional fire and emergency response personnel for our fire department.

As a condition of this award the City will be required to contribute a cost match in the amount of \$905,832.00 over three years of non-federal funds.
