REPORT: The U.S. Department of Homeland Security/FEMA, under the Assistance to Firefighters Grant Program – Operations and Safety Grant agreement, No. EMW-2017-FO-06904, has awarded the City of Yuma \$18,424.00 for the purpose of storing and laundering firefighting personal protective equipment (PPE). As a condition of the grant, the City shall contribute a cost match in the amount of \$1,842.00 (10% of the \$18,424.00 federal grant).					
The primary goal of the Assistance to Firefighters Grant (AFG) is to meet the firefighting and emergency response needs of fire departments and nonaffiliated emergency medical service organizations. Since 2001, AFG has helped firefighters and other first responders obtain critically needed equipment, protective gear, emergency vehicles, training and other resources necessary for protecting the public and emergency personnel from fire and related hazards.					
The award of this AFG will allow the Fire Department to use grant funds to purchase a specialized washer designed specifically for PPE cleaning and all required connections. In addition, specialized storage lockers will be purchased to allow storage of PPE away from the truck bay and diesel
