### CALL TO ORDER

**Mayor Nicholls** called the City Council meeting to order at 5:31 p.m.

**Edward Thomas**, Deputy Mayor gave the invocation. **Ricky Rinehart**, Deputy City Administrator led the Pledge of Allegiance.

### FINAL CALL - AGENDA ITEMS

**Mayor Nicholls** made a final call for the submission of Speaker Request Forms from members of the audience interested in addressing scheduled items on tonight's agenda.

#### I. MOTION CONSENT AGENDA

B.6 Liquor License: Vintage Social Club - Approve a Person Transfer, Series #6 Bar, Liquor License application submitted by Andrew F. Constanza, agent for Vintage Social Club located at 1891-A South Pacific Avenue, Yuma, Arizona. (LL15-23)

**Motion** (Knight/Craft): Move that the address stated on the Request for Council Action of Agenda item B.6, a Liquor License for the Vintage Social Club, be corrected from 1891-A South Pacific Avenue to 2891-A South Pacific Avenue, as stated on the application. Voice Vote: **approved** 7-0.

B. 13 Agreement: City Administrator - Authorize extension of an agreement and terms of employment with Gregory K. Wilkinson to serve as City Administrator for the City of Yuma.

**Wright** declared that at a mandatory meeting on August 13, 2015, the Attorney General's Office representative stated new Councilmembers had access to Executive Session minutes under Arizona law. Further stating that Arizona law 7.8.4 [Arizona Agency Handbook] says the following in regards to confidentiality of Executive Session Minutes:

The minutes of an Executive Session and all discussions that take place in Executive Session are confidential and may not be disclosed to anyone except that they may be disclosed to the following people: any member of the public body that meets in Executive Session and members who did not attend the Executive Session.

That pertains to the new members that have been elected to City Council. Out of fairness to all of the Councilmembers, our City Administrator's performance should be disclosed to all members so that we can objectively vote for this contract.

**Mayor Nicholls** affirmed that the new councilmembers have not requested that information and that the contract and evaluation are not necessarily tied explicitly together.

**Knight** stated that the Councilmembers received this agenda at the same time. If there is something on the agenda that a Councilmember has questions on, they need to request the information before the meeting so they can make an informed decision.

**Wilkinson** clarified that there is an existing law which does allow Councilmembers to access information from Executive Session minutes if they need the information to make a decision. However, it does not state the minutes can be perused through without reason.

**Moore** confirmed that the Councilmembers have the ability to go back and review Executive Session minutes and the support documents included as part of the Executive Session minutes.

**Shelton** thanked Councilman Wright for his consideration, but stated that he was not worried about reviewing the previous documents at this time. He understands that he will have the opportunity to give his input on an evaluation of the City Administrator later this year and he is okay with that.

Moving on, **Wright** noted that he has concerns about the 7% deferred compensation being in addition to the \$146,000 salary. **Nicholls** stated that Deferred Compensation provided by the employer is always above salary. The only difference from last year's contract is that we increased it 1%; from 6% to 7%.

**Wright** commented that staff received salary increases on July 1<sup>st</sup>. At the same time Mr. Wilkinson's contract went from \$136,000 to \$140,000, based on the same increase. If this contract is approved he will have received two increases in the 2015 budget year. **Nicholls** stated that is not correct. We set the contract last year, which changed the salary for Mr. Wilkinson. When the adjustments were made at the beginning of the year, Mr. Wilkinson's contract was already set. We did not amend or change his contract.

**Wilkinson** stated it is appropriate for leadership to take care of the employees first and this has been his first priority every year. Each time his agreement comes up for review, he asked for the appropriate compensation to match the employees. In January of 2015 his contract was adjusted by the same level. The increase negotiated for this contract is 1%, which again is the same as what was given to the employees on July 1, 2015.

**Mary Ann Easterday**, 3359 S. 15<sup>th</sup> Avenue, stated that after reading negative things about Yuma in the paper she had 10 things to express in support of the Yuma Community:

- 2. The Arizona Highways magazine's January issue contains a whole page about Yuma.
- 3. Parks and Recreation put together the bike paths in Yuma for the community and maps are available at City Hall.
- 4. The Extension Office is doing experiments with drones in Yuma which is really helping the agriculture community.
- 5. The re-opening of The Patio restaurant is good for the citizens and the food tastes great.
- 6. Businesses on Main Street have been open for business without any closing for repairs.
- 7. Businesses on 4<sup>th</sup> Ave are really starting to clean up and show their businesses off.
- 8. Recycling has now been available for a year and a half in Yuma.
- 9. The freeway under the 16<sup>th</sup> Street Bridge has beautiful landscaping.
- 10. Residents have been keeping up with the maintenance of their yards and neighborhoods.

**Carol Carr**, 1361 W. 16<sup>th</sup> Place, Announced the grand opening of Achieve Enterprise Services is scheduled for Saturday January 9, 2016 from 10:00 a.m. to 4:00 p.m. Achieve Enterprise Services is a total recycling service. She thanked the City for the first donation of 18 pallets of used computers which will assist with the employment of people with disabilities, including wounded warriors and veterans.
