**SUMMARY RECOMMENDATION:**

Adopt the Fiscal Year 2021 Proposed Annual Budget in the amount of \$249,330,796 which includes a Capital Improvement Program budget of \$51,444,152; an Operating Expenditure Budget of \$185,651,999; Interfund Transfers of \$12,041,577; and, Wastewater Interfund Borrowing of \$193,068. **REPORT:**

The City Administrator and City staff, after receiving City Council input, prepared the Fiscal Year 2021 Proposed Annual Budget for City Council's consideration. The result is a financial planning document incorporating the policy goals and objectives, as established by City Council, for the fiscal year beginning July 1, 2020 and ending June 30, 2021.
