TITLE:									
Change Order/Contract Increase: Downtown Raised Crosswalk and Spot Drainage Improvements									
SUMMARY RECOMMENDATION:									
Authorize a change order/contract increase to the approved construction contract with Gutierrez Canales Engineering, PC (GCE), in the amount not to exceed \$2,926.48 for construction services for Downtown Raised Crosswalk and Spot Drainage Improvements. (Engineering) (Jeffrey A. Kramer)									
STRATEGIC OUTCOME:									
This action aligns with City Council's strategic outcome of Respected and Responsible, as the contract amount increase accurately represents the actual cost of the work performed and allows for timely closeout payment to the contractor.									
REPORT:									

On September 16, 2020, City Council approved a contract for Construction Services with GCE for the Downtown Raised Crosswalk and Spot Drainage Improvements.

The scope of work included installing a raised crosswalk across Main Street in front of the Gowan Company building, along with modified curb, gutter and sidewalk adjacent to the new crosswalk. The improvements allow easier access across Main Street for the public who struggle with the standard sidewalk ramps. The raised crosswalk also helps as a traffic-calming feature, which limits vehicular speed in an area with on-street parking and many pedestrians.

The project also included the installation of a new catch basin with grate, curb, sidewalk, and sidewalk ramp just south of 3rd Street to alleviate a ponding issue within the storefront parking area.

At the City's request, GCE relocated the raised crosswalk, and adjusted some handicap parking spaces in order to align with the new crosswalk location. The revised location (approximately 100 feet south of the original location) was selected in an effort to satisfy late requests to accommodate the majority of pedestrians

that most frequently crossed Main Street. This new location interfered with stormwater drainage, and resulted in an increased scope of work and an increased project cost for which Change Order #1 (approved by City Council on 12/2/2020) was issued to GCE.

Upon completion of construction and verification of all quantities, it was determined that due to unforeseen underground conditions, additional removal and replacement quantities increased for storm pipe and concrete sidewalk. This resulted in an increase to the final project cost.

The cost impact is summarized in the following table:

Per Yuma City Code, Chapter 36, Section 36-34 Competitive Sealed Bidding: Change orders exceeding ten percent of the original contracts, where such amount in excess of the amount as provided for in A.R.S. §41-2535, as amended, require City Council approval unless otherwise provided for in the original contract as approved by the City Council.

Staff has reviewed the change order to ensure that the final closeout costs accurately represent the work required to complete the modified scope of work for the Downtown Raised Crosswalk and Spot Drainage Improvements, and recommends approval.
