**Kramer** clarified that the final dollar amount on this project is \$1.6 million and includes the cost of all of the improvements to Fire Station No. 4 and the rental of the trailer to serve as temporary living quarters. The City is being credited back the \$172,476.00 that City Council previously approved to purchase a modular building since it was not purchased due to the vendor being unable to fulfill the contract.
