I am pleased to inform you that the Attorney General's Office (AGO) has awarded the **Yuma City Attorney's Office \$7,000.00** from the Victims' Rights Fund for the period, July 1, 2020 through June 30, 2021, pursuant to Arizona Revised Statutes § 41-191.06 and § 41-191.08. Thankfully, despite funding shortfalls in the Criminal Justice Enhancement Fund (CJEF) and less than expected returns from the newly created \$9 assessment, we are happy to inform you that your FY 2021 award will be similar to your FY 2020 award. The AGO continues to work with the legislature and relevant stakeholders to address budgetary shortfalls and we remain committed to ensuring appropriate funding for the Victims' Rights Fund moving forward.

As you are aware, the purpose of the Victims' Rights Program (VRP) is to provide financial support to city, county and state entities that are affected by Arizona Revised Statutes Title 13, Chapter 40, *Crime Victims' Rights* and A.R.S. Title 8, Chapter 3, Article 7, *Victims' Rights for Juvenile Offenses*. In particular, VRP monies are awarded to offset costs associated with performance of duties that are mandated under victims' rights laws. I am confident this award will allow your agency to be successful and continue to include victims as an integral part of the justice process.

Prior to preparation of the Funding Agreement for your award a budget-proposal form will be available to you in our Grants Management (GMAN) System for your completion.
