REPORT:

Barry Olsen, on behalf of Caballeros de Yuma, Inc., has applied for a Special Event Liquor License for Midnight at the Oasis. The event will take place at Desert Sun Stadium located at 1280 W. Desert Sun Drive on Friday, March 3, 2017, from 8:00 a.m. to 12:00 a.m.; Saturday, March 4, 2017, from 8:00 a.m. to 12:00 a.m.; and Sunday, March 5, 2017, from 8:00 a.m. to 2:00 p.m.

As per state liquor requirements, the Yuma Civic Center has agreed to suspend a portion of their liquor license that covers Desert Sun Stadium on the dates and times listed above.

The application has been sent to Community Development, the Police Department, the Fire Department, Risk Management, City Engineering (Traffic) and Parks & Recreation. No objections have been received.

Upon City Council's recommendation of approval, the applicant will forward the application to the Arizona Department of Liquor Licenses and Control for final processing.
