## **AGENDA TOPICS**

- A. CONSTRUCTION SALES TAX: Only approve modifications to the construction sales tax system that create a long-term, sustainable policy that (i) maintains state and municipal revenues; (ii) ensures local revenues are received at the location in which the construction activity occurs; (iii) provides simplicity for the industry; and (iv) improves compliance.
- B. PUBLIC SAFETY PERSONNEL RETIREMENT SYSTEM (PSPRS): Adopt legislation that consolidates the current 233 PSPRS local boards to something significantly more efficient and uniform to assist in the efficient resolution of claims and ultimately save money and time, and provide more equitable resolutions to claims

- C. PTSD PRESUMPTION FOR PUBLIC SAFETY EMPLOYEES (HB2501): Urges the Legislature to put a moratorium on increased benefits for public safety employees.
- D. HIGHWAY USER'S REVENUE FUND (HURF): Restore HURF to statutory funding levels and explore alternative funding for road construction.
- E. OCCUPATIONAL LICENSING (SB1404): Protect the right for cities to issue business licenses and regulate occupations in the future as necessary.
- F. CURRENT LEGISLATION ISSUES: City Council discussion with legislators regarding current legislation affecting cities.
