TITLE:

Proposed League of Arizona Cities and Towns 2017 Resolutions

SUMMARY RECOMMENDATION:

Ratify the City Administrator's submission of the City of Yuma's policy ideas to the League of Arizona Cities and Towns ("League") for consideration as part of the League's 2017 legislative platform.

REPORT:

Every year the League of Arizona Cities and Towns ("League") prepares a legislative platform for the upcoming legislative session consisting of issues proposed by its membership in the form of Resolutions. Cities and towns are invited to submit policy issues on matters of statewide importance for consideration and adoption as part of the League platform.

The League assigns the policy ideas to a League Policy Committee for review. If the Policy Committee approves the proposal, the proposal will move to the League's Resolution Committee to draft a resolution. The draft resolution is then presented to the League executive committee for final approval. If approved, the resolution will become part of the League's 2017 legislative platform that the League will work with State legislators to implement during the 2017 legislative session.

The City was required to submit its policy ideas to the League by June 1, 2016. To ensure the City's policy ideas would be considered, the City Administrator submitted the following proposals:

1. Urges the League to develop and pass legislation that gives municipalities greater flexibility in annexing county islands.
2. Amends A.R.S. § 48-574 to authorize retention and detention basin improvement districts to levy and expend money to operate, maintain, repair and improve retention and detention basins within a municipality.

The City Council approved these same policy ideas last year. By approving this Resolution, the City Council is ratifying the City Administrator's submission of the City's policy ideas to the League for consideration as part of the League's 2017 legislative platform.
