REPORT: On February 17 th , 2016, City Council adopted Ordinance O2016-004, approving a land lease and the installation of a monopalm cellular tower owned by Verizon Wireless (VAW) LLC ("Verizon") on Cityowned real property located at 1028 W. Colorado Street.					
In order to power the cellular tower, APS will need to extend electrical service within the utility easement attached as Exhibit 1 and incorporated into the proposed ordinance.					
The utility easement will allow the development, operation, and maintenance of the monopalm cell tower and improve cellular service in the City. The easement also grants APS the right to permanently locate, reconstruct, repair, operate and maintain their electrical service lines and appurtenances on the described City-owned property.
