REFUSE COLLECTION AND DISPOSAL PROCEDURES AND REGULATIONS

ARTICLE I

Residential Refuse Collection and Disposal

- A. Residential customers are those properties within the City of Yuma used solely for a family or private residential domicile, including, but not limited to, single and two-family dwelling units, townhouses, condominiums, board and rooming houses, manufactured home parks, and manufactured home subdivisions.
- B. Residential customers shall receive refuse collection services twice per week (one pick up disposable refuse and one recycling pick up) at a cost of \$6.00 per month starting July 1, 2018. Effective July 1, 2019, residential customers shall receive refuse collection services at a cost of \$7.00 per month. This cost is referred to as the Residential Solid Waste Collection Fee.
- C. Effective July 1, 2020, the City Council may increase the Residential Solid Waste Collection Fee to residential customers for refuse collection services by a maximum of the current Consumer Price Index (CPI) or three percent (3%) per annum, whichever is less, to provide for cost increases for services. City Council will include any increases as a line item within the City's budget resolution for the year in which the increase is to take effect.
- D. Residential customers also pay an Environmental Solid Waste Fee. Effective July 1, 2018, the Environmental Solid Waste Fee will increase to \$6.75 per month and on July 1, 2019, will increase to \$7.25 per month. Effective July 1, 2020, the City Council may increase the Environmental Solid Waste Fee by a maximum of the current CPI or three percent (3%) per annum, whichever is less, through a line item in the City's budget resolution for the year in which the increase is to take effect.

ARTICLE II

Commercial or Extraordinary Services Fees Refuse Collection and Disposal

A. Commercial or Extraordinary establishments and rates includes, but is not limited to any establishment whose primary function or activity is for production of income, governmental agencies including Federal, State, County, and City or organizations, such as: service, fraternal, religious, charitable, and any other similar types. Multiple dwelling establishments encompassing three or more units, such as; RV parks, mobile home parks, apartment complexes, motels, and hotels. Exceptions to this requirement are individually owned and occupied units such as: mobile home subdivisions, townhouses, condominiums, cooperatives, and planned unit developments or any customer who desires additional service.

Billing Procedures

- A. Allowable refuse charges shall be billed by the City monthly at the same time and collected in the manner as water and sewer services charges as provided in Title 19, Section 193-65 through 193-73, of the Yuma City Code. Special billings for sanitation users adding or terminating services between regular billing periods shall be in accordance with Section 193-67 of the Yuma City Code: All user charges will commence at the date of application for sanitation service. In the event of failure to pay the refuse collection charges set forth herein the City may avail itself of the remedies set forth in Section 190-66 through 190-99 of the Yuma City Code and charge applicable late fees.
- B. Special collections of bulky, heavy, or uncontainable refuse, subject to the limitations of this Resolution, shall be at the rate per cubic yard of loose refuse, with a minimum of three cubic yards. Prior agreement must be made between the refuse generator and the Director of Public Works or his designated representative to initiate this service and the accompanying charges.
- C. Notwithstanding any other provisions to the contrary, the Director of Public Works, through his agent, is authorized to establish special rates for unusual or unique situations and/or requirements that may arise for any unforeseen extraordinary services, and such rates or charges shall be based upon costs relevant to the service provided.
- D. Customers shall assume responsibility for any damages, other than normal wear and tear, to containers assigned to them, and shall pay all costs for actual repairs or replacement resulting from negligence or abuse by the user.

ARTICLE IV

General Information

- A. Refuse containers shall not be overloaded to the extent that lids cannot be closed, or with material of such weight that the collection truck cannot lift the container. Containers so found shall not be collected until the excess material or weight has been removed. Charges for return for collection shall be as stated in Commercial or Extraordinary Services Fees table.
- B. Residential refuse and recycling shall be collected twice per week on Mondays and Thursdays or Tuesdays and Fridays. Normally no collections will be made on official City designated holidays. Normal hours of service will be between 6:00 AM and 5:00 PM.
- C. All customers shall adhere to the provisions of Chapter 190 of the Yuma City Code.
