REPORT:  A and I Builders, LLC is the owner of two properties located east of 1047 South Pagent Avenue (APN 664-90-121 and 664-09-122). The properties are located outside the City of Yuma and are currently vacant. The owner intends to construct a single family home on each lot. The owner has requested water service from the City of Yuma. Connecting to sanitary sewer is not possible at this time.  In accordance with City policy, the property owner has also requested annexation so that the properties may receive water service. However, the properties do not meet the minimum requirements under State law for annexation. Accordingly, as annexation of the properties are not possible at the current time, a Preannexation Development Agreement will be executed, kept on file, and utilized at such time that a larger annexation can be brought forward.
