VII. SUMMARY OF CURRENT EVENTS

Wilkinson reported that the Arbor Day Celebration will take place at Ponderosa Park on April 18th, from 9:00 a.m. to 10:00 a.m.

VIII. CALL TO THE PUBLIC

Harvey R. Campbell, 4155 E. Co. 13 ½ Street, Campbell asked the City Council and City staff to consider adding to the first City Council Agenda in June a section to discuss the Health Insurance Benefits provided to Councilmembers as it relates to the State Statute and the City of Yuma Charter. Campbell also requested the \$3.3-million-dollar use of impact fees for the Pacific Avenue Athletic Complex (PAAC) as shown in the 2017-2018 and 2018-2019 budget be discussed on the next City Council Meeting.

Audra Attaway, 1046 S. Appaloosa Lane, Attaway spoke about the perceived injustices brought against Sgt. Henry Valenzuela and the entire Yuma Police Department by City Administrator Wilkinson. Attaway spoke in regards to an award not given to Sgt. Henry Valenzuela due to his asking hard questions on financial decisions made by City Administrator Wilkinson that may have a negative impact on our community.

Karl Shaner, 2045 S. 14th Avenue Unit 78, Shaner thanked the City of Yuma for providing programs to educate citizens about what is going on in our town, such as the Citizens Police Academy and the Neighborhood Leadership Academy. Shaner also requested that the previous law regarding RV's parked in residential areas be brought back because the current law now states that an RV can park in a residential area for 48 hours and if they moved to another site that is a few feet away, then they can park for another 48 hours and he is not in agreement with such law.

Mary Ann Easterday, 3359 S. 15th Avenue, Easterday congratulated the Yuma Police Department for all the hard work they have been doing in our City to keep us safe. Easterday encouraged citizens of Yuma to help the Yuma Police Department by calling in to report if they see something going on. Easterday also mentioned the Recycling program being an on-going program in the City of Yuma. Lastly, Easterday asked the City Council to consider not having the speakers at the City Council Meeting give out their address for security purposes, given that the address information is already on the cards submitted to the City Clerk's office prior to the City Council Meeting.

Noemi Rodriguez, 1310 S. 3rd Avenue, Rodriguez advocated for the children who are victims of abuse and spoke on the statistics seen over the last year at Amberly's Place especially with the increase of crimes committed against children - 63% this quarter - in Yuma County alone and how significant the community's role was and is in making a safer environment for the children of Yuma. Rodriguez thanked the City Council for their support and asked for everyone to take action against child abuse.

John Lekan, 2559 S. Terrace Avenue, Lekan provided the City Council with his version of the telephone call held between City Administrator Gregory Wilkinson and himself on Monday March 25th, 2019. In this phone call, the 2018 Sworn-Supervisor of the Year Award nomination for Sgt. Henry Valenzuela was discussed. Based on the conversation held that day, Lekan's perception was that the jobs of anyone with authority and raises for the Yuma Police Department would be in jeopardy if Sgt. Valenzuela were to be approved for the Award.

Phil Clark, 4296 W. County 15th Street, Clark expressed his concern upon learning that there was an alleged complaint filed against him by the City Administrator seeking his prosecution for being a threatener and harasser of the City of Yuma. According to Clark, the City Council was not aware of the complaint filed against him, so he questioned the Charter and the control of litigation by the City Council and requested clarification on how the City Administrator supposedly is seeking his prosecution without their knowledge.

Henry Valenzuela, 2000 W. Country Lane, Valenzuela spoke about various topics such as health insurance, the \$100,00 contract limit and the denial of his award as the Sworn Supervisor of the Year by City Administrator Wilkinson. Valenzuela stated that once the City Administrator has lost the trust of the public and employees he is no longer effective. Valenzuela asked the Mayor and City Council to have the courage to do what needs to be done.

Will Katz, 340 W. 32nd Street P.O. Box 643, Katz thanked everyone for allowing him to be at today's City Council Meeting and exercise his constitutional rights. Katz asked the Mayor and City Council to take action based on the allegations presented against City Administrator Wilkinson and he commended the Councilmembers who, according to him, are taking a stand to do the right thing.

Eric Egan, 13393 E. 43rd Lane, Egan spoke about the perceived emotional decisions being made by the City Administrator Wilkinson in dealing with a group of individuals questioning the City's procedures. Egan expressed his concern over the comments made by the City Administrator against Chief Lekan over the past weeks. Egan encouraged the Mayor and Council to do the what they believe to be the right thing no matter what. Egan thanked Chief Lekan for standing up and clarifying the conversation between himself and the City Administrator.
