REPORT: The Edward Byrne Memorial Justice Assistance Grant Program is a provider of Federal criminal justice funding to state and local jurisdictions. Under the terms of the grant solicitation, the City through the Yuma Police Department submitted an application for funds to reimburse the City for expenses related to maintaining and improving interoperable communications and data sharing capabilities among criminal justice agencies in the Yuma area. The City seeks authority to execute the grant award in the amount of \$43,325.00 from the U.S. Department of Justice, Office of Justice Programs to reimburse the City for the cost of secure broadband wireless service for mobile data computing activities in the Police Department. This technology allows authorized law enforcement personnel the ability to share public safety information between law enforcement agencies using mobile devices over a secured private network. No matching funds are required by this award.
