Grant Award: FY 2019 Southwest Border Rural Law Enforcement Assistance Grant Award

SUMMARY RECOMMENDATION:

Authorize the City Administrator to accept and execute the FY19 Southwest Border Rural Law Enforcement Assistance Grant Award # 2019-DG-BX-0031 for the procurement of mobile data computers under the Yuma Area Border Initiative project. (Police/Patrol) (Susan Smith)

REPORT:

The Southwest Border Rural Law Enforcement Information Sharing and Interdiction Assistance Grants are innovative new programs designed to provide resources and assistance to fund rural law enforcement agencies along or near the southwest border of the United States. The grants support efforts to reduce violent crime, including drug-related crime and human trafficking. These grants are designed to enhance information sharing (including investigatory and intelligence data) and dedicated messaging capability among federal, state, local, and tribal agencies. The grants help procure previously identified specialized equipment to address crime issues that may be unique to the designated area.

The City seeks authority to execute the grant award in the amount of \$199,975 from the U.S. Department of Justice, Office of Justice Programs for the procurement of 38 mobile data computers, productivity application licenses, and wireless service plans for the City of Yuma Police Department. This technology allows authorized law enforcement personnel the ability to share public safety information between law enforcement agencies using mobile devices over a secured private network.
