I. GREATER YUMA ECONOMIC DEVELOPMENT CORPORATION MID-YEAR REPORT

Julie Engel, President/CEO of Greater Yuma Economic Development Corporation (GYEDC), presented the organizations mid-year report, as follows:

Economic Development Trends

- Workforce and talent will remain driving force in site selection, retention and expansion
- Companies are chasing talent at an all-time rate
- Work, live, play communities are magnets for innovation due to "lifestyle balance" employees are demanding
- Quality of K-12 education is a determinant factor
- Labor force markets are extremely constricted
- Inclusive economies are the next wave of talent mining
- Businesses and education must be responsible for learning and training/retraining of future workforce (CTE, STEM)
- Promotion of innovation, entrepreneurialism and local investment is paramount to diversifying economic base
- Urban areas are enjoying historic prosperity exceeding 2007 levels while rural regions have not reached pre-2007 recovery levels
- Economic mobility in rural areas remains a challenge
- Larger segment of rural population living in distressed zip codes
- Historic recovery masked by majority of growth in prosperous metros

Engel mentioned that Phoenix Economic Council is sponsoring a group of 40 members from Arizona-Mexico Commission to attend an event in Washington D.C. to discuss the United States-Mexico-Canada Agreement (USMCA) trade regarding the State of Arizona.

<u>Yuma 50</u>

- Military Support Organization
- Yuma Proving Ground has acquired many Aerospace companies to perform their testing at the grounds
- 2016-2017 YPG's Test revenue increased by \$2M
- 2017-2018 YPG's Test revenue increased another \$2M
- 2018-2019 YPG's Test revenue increased once again \$2M
- Marine Corp Aerostation is recruiting an additional squadron for the F-35
- Working with Sen. McSally and Congressman Grijalva in modifying some zones within Yuma County that are ideal for investment but currently do not qualify for the Opportunity Zone.

Yuma University

- Yuma University had its 1st Board Meeting recently
- Attended the Annual Memorandums of Understanding (MOU's) signing with Mexico
- 17 Universities are now in agreement between Mexico, Arizona Western College, University of Arizona and State of Arizona University
- Shared degrees and Instruction programs have been established
- Nursing students from Mexico are training at Arizona Western College, some are working at Yuma Regional Medical Center
- Martech Medical has become an economic development driver and is currently operating in Mexicali and Yuma

Discussion:

Deputy Mayor Knight asked about the Goldwater Range being long enough for the testing of missiles. **Engel** explained that the testing for the F-35 was held at the Goldwater Range because Yuma Proving Ground did not have the 100 kilometers needed for testing.

Shelton asked if Yuma is having an increase of people moving in to the area that are part of the companies mentioned in Engel's presentation and if there was an increase in property purchasing. **Engel** commented that there was not a large migration, but that they were investing by hiring local. **Shelton** mentioned that there is discussion on whether college is over emphasized because there is a detriment of trades, and asked Engel on her opinion about students going into the trades of being certified and avoiding the cost of college. **Engel** responded that there is mention amongst colleges that within the next 10 years, college degrees will be obsolete and that is due to companies such as Google, Intel, and NASA would rather train new employees in what they are doing, than simply hiring based on being a degree-holder. It is a different landscape today and technology is driving these changes because technology is changing so quickly. **Shelton** asked how the Space Port was brought to Engel's attention. **Engel** responded that she had attended a Science Tech Festival and met Jim Cantrell-creator of Vector who was a speaker at that festival. Cantrell mentioned that one of their biggest needs were space ports because they have to leave too many payloads on the ground because they're competing with commercial air traffic is very difficult. **Engel** stated she asked Cantrell if they would be willing to be

engaged at the ground level to help design this space port and help decide what an equitable lease rate is, so that they can get their investment back and Vector can have everything they need to be fully functional.

Deputy Mayor Knight asked how Yuma's cost of living compares with Maricopa and Pima County and if that is being tracked. **Engel** responded that it is tracked very closely and the cost of living is better. However, Yuma's property tax is higher due to Yuma bonding for schools. **Deputy Mayor Knight** stated Yuma has good education facilities. **Engel** agreed and mentioned that it is an investment well-made because the students are benefiting from it. **Thomas** asked Engel about a previous discussion in bringing a company such as Apple to the area. **Engel** explained that it will never happen unless there is a University in Yuma because companies like Apple align themselves with a higher education opportunity and not for degrees, but for training. However, Apple has invested in Yuma spending millions of dollars in Yuma's Crane School District and District One and this has made them very aware of this community.

II. 2019-2020 CDBG/HOME ALLOCATIONS

- CDBG is currently focusing on the Mesa Heights Neighborhood Revitalization Area
- HOME's Objective is to create or preserve affordable housing
- HOME funds are Awarded to Yuma County HOME Consortium
- HOME can be used County-wide

III. REGULAR CITY COUNCIL MEETING AGENDA OF MAY 1, 2019

Bushong mentioned to City Council and everyone in the audience that the Agenda packets are prepared two weeks in arrears and due to the recent retirement and reassignment of the City Administrator's position, the May 1st Agenda packet does contain the name of former City Administrator Greg Wilkinson. However, all current documents will be signed by Jay Simonton and any future documents will be prepared naming Simonton as the Interim City Administrator.

<u>Motion Consent Agenda Item B.2</u>: **Construction Services Contract: Fire Station #4 Remodel**-Authorize the City Administrator to execute a construction services contract for the Fire Station #4 Remodel project with Guaranteed Maximum Price 1 in the amount of \$172,476.00 to: CORE Construction, Inc., Phoenix, Arizona. (RFQ #2018-20000194 Engineering) **Deputy Mayor Knight** asked if the temporary structure is similar to a mobile home and if once it is owned will it be moveable for use as offices or housing spaces. **Kramer** stated that it is the plan, he also mentioned that this structure is more of an industrial-level mobile home, as it is essentially replacing a fire station on a temporary basis. **Deputy Mayor Knight** asked if there was a planned space to store it after its use on this project. **Kramer** stated this is still to be determined, but here are a couple City facilities being considered.

Deputy Mayor Knight asked if anyone knew the size of that structure. **Zahn** mentioned that the trailer is 68 feet long and approximately 16 feet wide. It is a 3 bedrooms, 2 bathrooms and it has a full-size kitchen and laundry area in addition to some office space.

Deputy Mayor Knight asked if the \$1.5M budget mentioned on the RFCCA for Fire Station #4 was the amount that was going to be spent for the Guaranteed Maximum Price (GMP). **Kramer** stated that for this Fiscal Year it is part of the \$1.5M, however, the Fire Department actually added a little bit of additional money to the budget for next year in order to obtain a couple of things they felt were critical to the project, ultimately the total cost of the project for the 2 GMPs combined are approximately \$1.6M. However the final construction values are still being negotiated.

Motion Consent Agenda Item B.3: Contract Increase: Projectmates Software Subscription Expansion- Authorize an increase in the Projectmates Program Management Information System (PMIS) subscription offered by Systemates, Inc., by adding an expansion package through the cooperative purchase agreement originated by the Texas Department of Information Resources, for an estimated additional expenditure of \$17,303.81 which increases the total estimated cost to \$141,203.81. (Engineering)

Deputy Mayor Knight asked if the increase software capability will increase the efficiency with a reduced staff in the Engineering Department. **Kramer** stated that in general, the intent was improving efficiency, improving consistency, and ease of accessibility not only for staff but for our design professional and construction partners. The new software has the capability to generate lists from your mobile device while you are in the field. It creates a running list that then has completion and verification check-offs built in to it. It keeps an audit trail, a version history and can include the plat drawings, correspondence, test results, and all of that information contained within this one simple area, so that the residential subdivision developers can access this system and be able to use it. It should really simplify communication and working together more collaboratively.

<u>Motion Consent Agenda Item B.6</u>: **Final Plat: The Fields at Castle Dome Subdivision-** Approve the final plat for The Fields at Castle Dome Subdivision. The property is located north of the intersection of 8th Street and Castle Dome Avenue, Yuma, AZ. (Community Development/Community Planning)

Deputy Mayor Knight asked for a status on roundabout access to the Castle Dome Subdivision-The Fields. **Kramer** stated that they had a conceptual plan prepared that looked at full roundabout implementation and what an interim condition might look like. It actually fit much better than anticipated and the pricing would lead to a small contribution from the City to make the interim happen. If we can confirm that funds are available, then we will proceed with the design and implementation of that interim roundabout using the developer's money for the majority portion. **Shelton** asked for clarification of the location. **Kramer** informed that it is to the north of Giss

Parkway/A Street alignment. **Deputy Mayor Knight** also responded that it actually does exist, it just ends at A Street and Giss Parkway.

Shelton asked if the project was possible without expanding the roundabout. **Kramer** explained that it is not possible. An application submitted for a Federal Safety Grant to do the expansion of the roundabout is in place. The interim would be for a two-lane roadway, but the ultimate will be for a four-lane roadway. If the grant is approved, it will take a few years for construction to be completed.

Introduction of Ordinance O2011-018: Compensation and Benefits for Municipal Judge- Establish compensation and benefits for the office of Municipal Judge. (Human Resources)

Deputy Mayor Knight asked if the Municipal Judge had not received a raise since 2011. Welch confirmed that to be true. **Deputy Mayor Knight** asked how does the salary being recommended compare to what the current salary is. Welch stated that it would be a 5% increase from current salary.

IV. ADJOURNMENT/EXECUTIVE SESSION

Motion (Thomas/Watts): To adjourn the meeting into Executive Session. Voice vote: **adopted** 5-0 (McClendon and Mayor Nicholls absent). The meeting adjourned at 7:00 p.m.
