TITLE:

2019 City of Yuma General Election Canvass

SUMMARY RECOMMENDATION:

Adopt the results of the November 5, 2019 City of Yuma General Election through the official canvass.

REPORT:

The City of Yuma General Election was held on Tuesday, November 5, 2019, for the purpose of electing candidates to fill three at-large seats for the office of City Councilmember. The results of the election are contained in the official canvass to be adopted by this resolution.

As required by the Yuma City Charter and Arizona Revised Statutes (ARS) §16-642, the City Council shall declare by resolution the results of the election not less than six days nor more than 20 days following the election. A.R.S. §16-646 requires the official canvass to contain certain information, which has been included in the resolution.

The resolution declares that Mike Shelton, Ema Lea Shoop and Chris Morris are duly elected to the offices of City Councilmember for the full term of four years, beginning January 1, 2020.
