Arthur Ramo, on behalf of Best Liquor, 138 E. 16<sup>th</sup> Street, has applied for a Series #9 Liquor Store/Owner Transfer. The liquor license is being transferred from ARS-Fresno LLC, owner of Porter's Market, which previously operated at the same location.
