Grant Award: Arizona Companion Animal Spay and Neuter Committee

SUMMARY RECOMMENDATION:

Authorize the City Administrator to execute the required documents with Arizona Companion Animal Spay and Neuter Committee (ACASNC) to disburse awarded grant funds to support community spay and neuter surgeries. (Police/Administration) (Susan Smith)

REPORT:

Yuma Police Department's (YPD) Animal Control Services unit (Animal Control) is tasked with decreasing the number of stray animals in the community. The ACASNC has awarded \$10,000 in grant funding to Animal Control to spay or neuter domesticated animals and an additional \$10,000 in grant funding to spay or neuter feral animals, for a combined total of \$20,000 in grant funding.

The funds will allow Animal Control to direct \$20,000.00 to the Humane Society of Yuma to increase spay and neuter efforts in the community. Animal Control will issue vouchers to the Yuma County Humane Society when it renders spay or neuter services. Animal Control will use the grant funds to pay the authorized fees.

All funds must be expended by August 15, 2020, and any unspent funds must be returned with a final follow-up report.
