MC2019-071 – Annexation Area No. ANEX-24913-2019: Riedel Construction Company (consider the annexation of approximately 21.2 acres of property located east of the southeast corner of Avenue 8 ½ E and 40<sup>th</sup> Street) (DCD/Planning)

**Mayor Nicholls** opened the public hearing at 5:42 p.m.

**Albers** presented the following information:

- The subject property is an approximately 21.2-acre undeveloped parcel located east of the southeast corner of Avenue 8 ½ E and 40<sup>th</sup> Street, inclusive of the 40<sup>th</sup> Street right-of-way on the north
- The applicant intends to develop a single-family home subdivision if they are successful with the annexation, General Plan amendment, and future rezoning

**Motion** (Thomas/Knight): To close the Public Hearing. Voice vote: **approved** 7-0; Public Hearing closed at 5:43 p.m.

## **Discussion**

**Shelton** asked if anyone is opposed to the annexation for any reason. **Albers** replied that no comments have been received with regard to this annexation.

Ordinance O2019-019 – Adoption of North Service Area Development Fees (based on amendments to the Infrastructure Improvements Plan including the addition of South Mesa Community Park and change in designation of 28<sup>th</sup> Street between Avenue C and 45<sup>th</sup> Avenue from arterial to collector) (Engineering)

Mayor Nicholls opened the public hearing at 5:45 p.m.

**Thomas** asked what the difference is between the current fees and the staff recommended fees that include the design for the South Mesa Park. **McGarvie** stated that it is a \$175 increase for single-family, a \$29 increase for multi-family, and a \$77 increase for all other types.

## **Speakers**

Harvey Campbell, 4155 E. County 13 ½ Street, President of betteryuma.org, explained that his objection is not to the amount of the increase itself, but to collecting fees from a specific area that already contributed \$3 million in Development Fees which were used for the Pacific Avenue Athletic Complex (PAAC) rather than a local park. Development Fees harm development and places the burden of growth onto homebuyers, and consequently many municipalities throughout the United States are choosing to eliminate them.

Mayor Nicholls asked where the \$3 million figure came from. Campbell replied that it came from research conducted by betteryuma.org members on the transfer of monies from Development Fees to the PAAC. Mayor Nicholls noted that the Parks and Recreation portion of the Development Fees only nets somewhere around \$300,000 or \$400,000 per year. Campbell responded that while he could not address the specifics at this time, he would put the information in writing and send it to City Council. Shelton asked if Campbell was ever contacted regarding the proposed Development Fee increase. Campbell stated that he has not had any contact with City staff regarding the increase.

**Will Katz**, 340 W. 32<sup>nd</sup> Street P.O. Box 643, stated that regarding the \$3 million figure, he believes Campbell is referring to the approximately \$2.6 million in Parks and Recreation Development Fees spent on the PAAC: \$994,000 in FY 12-13, \$1.1 million in FY16-17, and \$555,000 in FY17-18 as reported in the Development Fee Annual Reports for those respective years. The population in the North Service Area is expected to increase by 24,000 by 2035, and it does not make sense to expect those 24,000 to bear the \$7.6 million cost to design and construct a new park.

**John Courtis**, 2522 S. Elmwood Drive, displayed newspaper articles from January 24<sup>th</sup> and September 23<sup>rd</sup> which both indicated that Development Fees were going to be kept flat. It was not mentioned anywhere in those articles that this was conditional. Fees are not paid by the builder, but rather passed on to the homebuyer and in the end they only account for a fraction of the City's revenue. He asked that the fees remain where they are.

**Wayne Benesch**, 350 W. 16<sup>th</sup> Street, echoed that Development Fees harm development and stifle growth. He suggested that City Council explore other means of raising funds, and then move on to studying methods

by which the current fees can be reduced. Furthermore, fees are added to the cost of the ultimate homeowner so reducing fees will make the market more appealing to buyers and help the City maintain momentum.

**Motion** (Knight/Thomas): To close the Public Hearing. Voice vote: **approved** 7-0; Public Hearing closed at 6:13 p.m.

### Discussion

- \$3 million would be equal to all of the Parks and Recreation Development Fees from throughout the entire City for the last 17 years (Wilkinson)
- The land that the PAAC was built on was paid for with pre-2012 Development Fees; Development Fees must be spent within 10 years (**Wilkinson**)
- A park would normally be paid for in one of three ways: Development Fees, an Improvement District, or by a developer as part of a new development (**Shelton/Wilkinson**)
- The park can remain in the Infrastructure Improvements Plan without funding; this would allow it to be built in the future if a funding source is found (Mayor Nicholls/Wilkinson)
- Development Fees were cut in half in 2013 to encourage development at a time when developers were competing with banks selling homes far below market (**Watts/Wilkinson**)
- Development Fees help spread out the cost of roads and other infrastructure, which would be difficult for developers to fund on their own (Watts/Wilkinson)

Mayor Nicholls recessed the meeting for a short break at 6:29 p.m. and reconvened at 6:43 p.m. with the above-noted parties present.

**Motion** (Knight/McClendon): To amend Section 1 of Ordinance O2019-019 to replace the proposed fees for Parks and Recreation to read: Single-Family \$1,003, Multi-Family \$699, and All Other Types \$582, and carry over total fees as noted, and reintroduce the ordinance as amended.

**Mayor Nicholls** asked what the total fees will be, including the amended Parks and Recreation fees. **Wilkinson** stated that the totals would be \$2,572 for single-family, \$1,957 for multi-family, and \$1,498 for all other types.

Voice vote: **approved** 7-0.

**Bushong** displayed the following title:

### **Ordinance O2019-019**

An ordinance of the City Council of the City of Yuma, Arizona, amending the Yuma City Code by updating and amending the North Service Area Development Fees set forth in Chapter 157-06 through 157-13 (for areas within the City limits north of 56<sup>th</sup> Street) (Engineering)

**Motion** (Thomas/Knight): To recess to Executive Session. Voice vote: **approved** 7-0. The meeting recessed at 6:44 p.m.

The meeting reconvened at 7:19 p.m. with the above-noted parties present.

#### FINAL CALL

**Mayor Nicholls** made a final call for the submission of Speaker Request Forms from members of the audience interested in speaking at the Call to the Public.

## VI. APPOINTMENTS, ANNOUNCEMENTS AND SCHEDULING

**Motion** (Knight/Thomas): To appoint Sandra Nevels to an unexpired term on the Residential Advisory Board with a term expiration of December 31, 2020. Voice vote: **approved** 7-0.

**Motion** (Shelton/Watts): To reappoint Christopher Harmon to the Housing Authority of the City of Yuma with a term expiration of December 31, 2023. Voice vote: **approved** 7-0.

**Motion** (Knight/Watts): To appoint Liz Laster as the Chair and Connie Jerpseth as the Vice-Chair to the Housing Authority of the City of Yuma. Voice vote: **approved** 7-0.

Knight, Shelton, Watts, Thomas, Miller, and Mayor Nicholls reported on events and meetings they have attended during the last two weeks and upcoming events of note.

**McClendon** requested that a committee be formed to review the City Charter. **Wilkinson** stated that a motion will be placed on the dais at a future meeting.

**Shelton** questioned the safety of groups holding demonstrations at the intersection of 16<sup>th</sup> Street and 4<sup>th</sup> Avenue that involve bullhorns and amplified music. **Chief Smith** responded that groups usually contact the Yuma Police Department (YPD) ahead of time, and as long as they stay on the sidewalk and follow all rules and regulations no action is taken. YPD has not received any complaints, and no safety hazards have been observed.

**Motion** (Knight/Thomas): To schedule a Special Worksession/Roundtable for April 16, 2019, at 4:00 p.m. in City Hall Conference Room #190 for the purpose of discussing the City's budget. Voice vote: **approved** 7-0.

### VII. SUMMARY OF CURRENT EVENTS

**Wilkinson** recognized Engineer Robert Campbell, Westmoor Electric, and the Public Works Department for their teamwork in getting the traffic signals at 24<sup>th</sup> Street and Arizona Avenue back up and running.

#### VIII. CALL TO THE PUBLIC

**Deborah Rapp**, 2460 S. Kathleen Avenue, urged City Council to protect the citizens of Yuma from the influx of undocumented immigrants into Arizona.

**Harvey Campbell**, 4155 E. County 13 ½ Street, asked that City Council take the City Administrator's recent behavior into consideration regarding the renewal of his contract.

**Phil Clark**, 4296 W. County 15<sup>th</sup> Street, questioned who authorized the addition of City Council to the City's health insurance plan.

**Will Katz**, 340 W 32<sup>nd</sup> Street P.O. Box 643, spoke regarding allegations that citizens who ask questions about City operations are having criminal complaints filed against them.

**Henry Valenzuela**, 2000 W. Country Lane, stressed the importance of citizens being able to question their government and have those questions answered without fear of retribution.

**Nathan Townsend**, 4091 S. Sunlight Way, read the poem "If You Could See Me" by Michael Cloutier and spoke in support of the men and women who protect the community not just as a job but as a calling.

**Paul Corcaran**, 6340 E. 45<sup>th</sup> Place, questioned why Sergeant Henry Valenzuela was refused the YPD award.
