Grant Award: Victim Rights Program

SUMMARY RECOMMENDATION:

Authorize the City Administrator to execute the Award Agreement between the Arizona Attorney General's Office and the City of Yuma for the Victim Rights Program, in the amount of \$7,000.00 for Fiscal Year 2021. (City Attorneys Office) (Richard Files)

REPORT:

On January 1, 1992, the Arizona Victim Rights Law was enacted. In order to offset direct costs incurred by prosecutorial agencies in implementing the victim rights law, a portion of the Criminal Justice Enhancement Fund assessment provision was enacted. These assessments are essentially surcharges that are added to misdemeanor fines. The money collected is placed in a Victim Rights Fund and disbursed annually through the Attorney General's Office Victims' Rights Section.

The City Attorney's Office applied for and has been awarded \$7,000.00 to help offset personnel costs and postage costs incurred by the City Prosecutor for victim rights services in Fiscal Year 2021. Staff recommends execution of the Award Agreement.
