REPORT: On February 26, 2015, Yuma City Council approved an IGA between the City and YCIPTA in which YCIPTA would pass funds from Grant Number AZ-90-X132 and AZ-90-X127 to the City to help with funding the improvement and rehabilitation of the Hotel Del Sol as a multimodal transportation center. The initial term of the IGA expired August 26, 2017, but was extended through the First Amendment to the IGA through August 31, 2018. The parties desire to extend the term of the IGA until December 31, 2023 to allow the City to use these grant funds to help support the rehabilitation of the Hotel Del Sol.
