Authorize the City Administrator to execute a contract for Construction Services for the Thomas F. Allt Utilities Complex to the lowest responsive and responsible bidder in the amount of \$5,096,166.28 to:

REPORT:

The Thomas F. Allt Utilities Complex, located on an approximately 3-acre site at 200 W. 13th Street, will provide a consolidated location for the various divisions of the Utilities department.

The contractor shall construct the following: an approximately 20,000 square-foot single story building; site improvements for the project site; offsite improvements consisting of wet and dry utility extensions, pavement and landscaping; and any other improvements as identified in and in accordance with the approved contract documents.

The project is required to be complete within 300 calendar days from the notice to proceed date.
