CALL TO ORDER

Mayor Nicholls called the City Council meeting to order at 5:35 p.m.

INVOCATION/PLEDGE

Pastor Tyrone Jones, Church for the City, gave the invocation. **Police Chief Susan Smith** led the City Council in the Pledge of Allegiance.

FINAL CALL

Mayor Nicholls made a final call for the submission of Speaker Request Forms for agenda related items from members of the audience.

PRESENTATIONS

Arizona Education Progress Meter Proclamation

Mayor Nicholls read the Arizona Education Progress Meter Proclamation supporting the statewide goal of 60% of adults possessing a degree, certificate or industry credentials by 2030.

Solid Waste and Recycling Services Contract

Olea presented an update on the status of the City's solid waste and recycling contract as follows:

- Background Information
 - Solid Waste is an Enterprise Fund
 - The City is required to collect enough funds to maintain operations
 - o 2017 Rate Study
 - 10-year financial plan identified a gradual rate adjustment through the annual budget process of a projected 3% (around 40-50 cents per year) starting in 2022

- Impacts to Municipal Recycling
 - Many Arizona municipalities began reporting that they were downsizing or eliminating their programs
- Change in Recycling Contamination Acceptance
 - China's rate of acceptable contamination decreased from 3% to 0.5%, resulting in additional costs to the vendors who process the materials
- Proposed Contract
 - o Transfer station will remain at Avenue 3½E and 32nd Street
 - o 10 year contract with option to renew for two additional five-year periods
 - Trash disposal \$28 per ton
 - Copper Mountain Landfill in Wellton, Arizona
 - Recycling processing \$28 per ton
 - Annual rate increase of 3%
- Vendor Agreements
 - o Hire three additional staff members solely to process recycling
 - o Expand existing transfer station by 5,000 square feet
 - o Process recyclables locally for the next 10 years
 - Revenue Sharing
 - Vendor will receive 80% and the City 20% for the first
 - After the revenues hit \$125,000, the City will receive 80% and the Vendor 20%
- Transitional Period
 - Recyclables, which are currently processed in Imperial Valley, California, will be processed locally no later than July 1, 2021
 - o Collection will remain the same for green and blue bins
 - Recyclables will be landfilled for a period of 8 months
 - Drop-off recycling will be available during the transition period
- Recycling Drop-Off Program
 - o November 2020 through June 2021
 - o Cost not to exceed \$31,500
 - Up to five locations managed by vendor
 - Avenue A and 4th Street
 - Avenue A and 36th Street
 - 24th Street and 33rd Avenue
 - 24 Street and 33 Avenue
 24th Street and Avenue 7½E
 - 40th Street and Avenue 8E

Discussion

- From November 2020 to June 2021 recyclables that are collected from residents' curbside bins will be taken to the landfill; those that are collected at the drop-off sites will be recycled (**Knight/Olea**)
- Recyclables have never been processed locally so it is difficult to estimate when revenues will reach \$125,000 (**Knight/Olea**)
- The trash disposal fee is being reduced by the vendor from \$30.70 to \$28.00 for a two-year period, and then in 2023 the 3% annual increase will go into effect (**Knight/Olea**)
- Two qualified vendors responded to the Request for Proposal, and the proposed contract reflects the negotiations with the selected vendor (**Shoop/Olea**)

- Residents are encouraged to continue using the blue bin for recycling and the green bin for trash throughout the transition period so there will be no confusion (Watts/Olea)
- The eight-month transition period is the maximum amount of time the vendor has to construct and begin operations at the local recycling facility (**Watts/Olea**)
- The existing solid waste contract does not include a fee for recycling, however the vendor receives 90% of revenues in part because the vendor provided the blue recycling bins (**Morris/Olea**)
- Recyclables were a commodity that were generally being shipped overseas; the domestic market is developing, which will hopefully help raise prices (Morris/Peter Sternberg Republic Services)
- The recycling processing center will add three positions. They will also allow nearby municipalities such as Somerton and San Luis to utilize the facility (Morris/Olea)
- It is not anticipated that the volume of recyclable material will exceed capacity because the processing center will only handle what is generated locally (**Morris/Sternberg**)
- The \$28.00 recycling processing fee covers processing, transportation, and sale of the processed materials (Mayor Nicholls/Sternberg)

Future Scheduling of City Facilities

Deputy City Administrator, **Simonton**, began by addressing a concern recently expressed on social media regarding the condition of a City facility. He stated an independent review will be conducted of all Parks & Recreation facilities to ensure that needed maintenance and repairs take place in a timely manner. **Simonton** continued by providing the following overview of Parks & Recreation activities:

Discussion

- Anyone in the community who has a concern regarding a facility can call (928) 373-5018 to report the issue; a phone call will enable a much quicker response than a post on social media (**Mayor Nicholls/Simonton**)
- Local sports groups utilize the PAAC almost every single night of the week in addition to the scheduled tournaments (**Shoop/Simonton**)
- People are now allowed to bring their own food and beverages into the PAAC; beer permits are also available for purchase through the Parks & Recreation Department (**Shoop/Simonton**)
- Tournaments are currently being limited to 75 teams, but organizations are interested in scheduling tournaments with 100 or more teams (**McClendon**)
- Outdoor sports and activity opportunities will be the top factor that will bring tourism to Yuma as the weather changes and will be promoted by Parks & Recreation (McClendon/Simonton)
- Winter visitors are taking recreational opportunities into consideration when deciding whether to come back to Yuma in the fall and winter (**McClendon**)
- To ensure that Centers for Disease Control and Prevention guidelines are being followed to keep participants healthy, capacity at the PAAC will be cut from six fields to three fields and about 50 spectators per team (**Shelton/Simonton**)
- Drive-in movies have been discontinued now that theaters are allowed to be open at reduced capacity, although there may be some special engagements coming up (**Shelton/Simonton**)

Motion Consent Agenda Item B.3 – Bid Award: Downtown Raised Crosswalk and Spot Drainage Improvements (execute a contract for construction services in the amount of \$75,891.42 with Gutierrez Canales Engineering, PC, Yuma, Arizona) (Bid #2021-20000018) (Eng)

Discussion

- The lowest bidder was considered non-responsive because they did not turn in all of the required documentation to make their bid complete (**Knight/Simonton**)
- The raised sidewalk will be very similar to those that can be found between Second Street and Third Street, although they will not be quite as wide (**Knight/Simonton**)

<u>Motion Consent Agenda Item B.8</u> – Change Order: Police Storage Facility (execute a change order in the amount of \$370,205 for design services by Architekton, Inc.) (Contract #2020-20000004) (Eng)

Discussion

• The first phase of the storage facility will be used for impounded and/or damaged vehicles, though long-term it will be used for all forms of property (**Knight/Kramer**)

• Overflow evidence will also be stored at the facility in the future as YPD is outgrowing the current evidence storage facility (**Knight/Smith**)

Motion Consent Agenda Item B.2 – Bid Award: Catalina Drive & Palo Verde Street Pavement Replacement (execute a contract for Construction Services in the amount of \$893,551.95 with Gutierrez Canales Engineering, PC, Yuma, Arizona) (Bid #2020-20000163) (Eng)

Discussion

• It is difficult to determine the exact cause of a price difference between bids because there are many possible factors (Watts/Kramer)

• Construction costs are steadily increasing, particularly materials costs, and labor costs are beginning to increase after staying relatively flat for several months (Mayor Nicholls/Kramer)

Motion Consent Agenda Item B.7 – Contract Award: Hotel Del Sol Multi-Modal Transportation Center (execute a contract for design-build services in the amount of \$1,015,000 with CORE Construction, Inc., Phoenix, Arizona) (Bid #2020-20000136) (Eng)

Discussion

- The multi-modal center is intended as more than just a place to purchase tickets; it would also serve as a hub where travelers can change between modes of transportation (**Mayor Nicholls/Shoop**)
- This contract is only for the design elements of the project, including a structural analysis which will identify the historic building's specific construction needs (**Shoop/Simonton**)
- This project was designated a Multi-Modal Transportation Center in part to qualify for transportation-specific grants. However, since the transportation grants were not awarded to the City, other uses for the building and types of funding can be explored (**Knight**)

- The City can apply for grants to convert the Hotel Del Sol into affordable housing, which may be a better return on its investment (**Shoop**)
- The building in its current condition either needs to be restored or demolished, and the design element is necessary in order to know what is possible (**Shelton**)
- The design phase must take place regardless of the intended use of the building; if this design contract is not approved, the grant funding will be lost (**Morris**)
- As it is, the building is a blight on the Downtown area; this is an opportunity to restore it to its former glory and increase Yuma's economic development (Watts)

- **Miguel Miranda**, City resident, expressed opposition to spending any more taxpayer money on the Hotel Del Sol when there are other areas such as roads that are more in need of funding.
- Gary Wright, City resident, spoke in opposition of spending tax revenues on the Hotel Del Sol, stating that the funds are better spent on public safety and roads.
- **Bob Cuckler**, non-resident, posed several questions including how much the Hotel Del Sol project will actually cost the City, how it will be funded once the design phase is completed, and what is the best use of the property.
- **J.P. Mahan**, City resident, spoke in support of bringing a bike park to Yuma, noting that such facilities are popular across the country. He asked for guidance in how to move forward and how to partner with the City to accomplish this goal. **Mayor Nicholls** directed **Rodriguez** to provide **Mahan** with information on the process.

• **Gary Wright**, City resident, suggested that the City consider outsourcing trash and recycling collection as it may result in a cost savings.
