II. RESOLUTION CONSENT AGENDA

Responding to the Mayor's question from the previous night, **Symer** clarified that the basin will be serving both Phase 1 and Phase 2. The current agreement, however, is for Phase 1 only. As Phase 2 comes on board, they will pay their proportionate share of the basin as a whole.

Motion (Knight /McClendon): To adopt the Resolution Consent Agenda as recommended.

With no speakers and no further discussion, Bushong displayed the following title:

Resolution R2018-003

A resolution of the City Council of the City of Yuma, Arizona, declaring its intention to create Municipal Improvement District No. 104, Serving Desert Sky Unit No. 1, to operate, maintain and repair landscaping improvements included within, near and adjacent to the retention and detention basins and parkings and parkways and related facilities together with appurtenant structures of Desert Sky Unit No. 1 (40th Street and Avenue 7 ½ E) (DCD/Planning)

Roll call vote: adopted 7-0.

III. Adoption of Ordinances Consent Agenda

Shelton expressed concern that only the initial property owners were notified of the annexation. He feels there needs to be an expansion of notification for all those who are affected by an annexation, especially since residents spoke out that they were not properly notified.

At the request of Councilmember Thomas, **Albers**, explained the notification process for annexations as follows:

- The City of Yuma follows State Statutes
 - The property is posted in three different locations visible to neighbors
 - A display add is published in the paper
 - Property owners who are within the annexation boundary are notified

Albers explained that an annexation only changes the taxes paid by the properties that are involved in the annexation. It does not make it any more intense than it was, nor does it change the General Plan. When researching what other communities have done, Albers found that most communities follow State statute requirements and some go beyond. Mayor Nicholls asked who pays for the notification including the newspaper article and the distribution of information. Albers replied there are no fees on their fee schedule for annexations and that the costs are borne by the City of Yuma. Albers continued stating there is an application fee for rezoning cases and a base fee with General Plan Amendments based on the number of acres to cover some of the costs in processing those requests. Mayor Nicholls opined, and Albers agreed, that there would be a costs associated for going above and beyond.

Motion (Knight /Miller): To adopt the Ordinances Consent Agenda as recommended.

Bushong displayed the following title:

Ordinance O2018-012

An ordinance of the City Council of the City of Yuma, Arizona, annexing to the City of Yuma, a portion of Section 17 of Township 9 South, Range 22 West of the Gila and Salt River Base & Meridian, Yuma County, Arizona, and amending Chapter 154 of the Yuma City Code, as amended, designating the zoning of certain property to the Agriculture (AG) Zoning District, and amending the

zoning map to conform with the annexation, pursuant to the provisions of Title 9, Chapter 4, Article 7, Arizona Revised Statutes and its amendments (property generally located at the southwest corner of Avenue 6E and 44th Street) (DCD/Planning)

Roll call vote: adopted 7-0.

Ordinance O2018-013

An ordinance of the City Council of the City of Yuma, Arizona, referencing Chapter 154 of the Yuma City Code, rezoning certain property located in the Light Industrial /Infill Overlay (L-I/IO) District to the Low Density Residential/Infill Overlay (R-1-6/IO) District and amending the Zoning Map to conform with the rezoning (approximately 0.16 acres located at 978 S. 1st Avenue) (DCD/Planning)

Ordinance O2018-014

An ordinance of the City Council of the City of Yuma, Arizona, amending Title 15 of the Yuma City Code, Chapter 154, zoning, by amending Article 19, Sections 19.02, 19.03, and 19.09, and adding Section 19.11, related to Personal Wireless Communications; and providing penalties (Zoning Code text amendment to include guidelines and development standards for personal wireless communication facilities in the public Right-of-Way) (DCD/Planning)

V. **PUBLIC HEARINGS**

<u>R2018-004: General Plan Amendment: 1421 S. Avenue B</u> - Deny the request to amend the City of Yuma General Plan to change the land use designation from Medium Density Residential to High Density Residential, for property located at 1421 S. Avenue B. The applicant is South Avenue B L.L.C. (GP-19696-2017). (Community development/Community Planning) (Laurie Lineberry)

Mayor Nicholls, explaining that the applicant made a request to continue Resolution R2018-004 and called for the motion.

Motion (Knight/Watts): To continue the public hearing and related actions regarding the General Plan Amendment for South Avenue B, L.L.C., to the July 18, 2018 Regular City Council Meeting, at the request of the applicant. Voice vote: **approved** 7-0.

Mayor Nicholls reported on his trip to Washington DC with the City Administrator. Meetings were held with Senator McCain's staff, Senator Flake and staff, Representative McSally, Representative Sinema, Representative Gosar and Representative Gijalva's staff regarding priorities for Yuma. Meetings were also held with the Department of Defense, Department of Transportation and the Environmental Protection Agency. Mayor Nicholls hoped to meet with the Federal Communications Commission, but given the fact that the City of Yuma filed a complaint it was not possible to meet with them. **Mayor Nicholls** reported that the Yuma Sun put out a great article summarizing the trip and was topic specific for those who want more information. **Mayor Nicholls** stated it was time well spent as evidenced by a \$10 million investment for a home supporting our Veterans. Tackling the Veteran's Home is something that started back during his first term and has taken four to five years to come to fruition.
