2. Approve a Special Event Liquor License application submitted by Nerissa Freeman on behalf of St. Francis of Assisi School for the 'Benefit for the Children' event. The event will take place at St. Francis of Assisi School, 700 W. 18th Street, on Saturday, April 25, 2020, from 5:00 p.m. to 12:01 a.m. (SP20-10) (Admin/Clk)
3. A resolution of the City Council of the City of Yuma, Arizona, authorizing the City of Yuma to enter into a Mutual Aid Agreement with Rural Metro Fire Department, Inc. (for cooperative fire protection and emergency medical services) (Fire)

IV. INTRODUCTION OF ORDINANCES

Ordinance O2020-005 – Rezoning of Property: East of the Southeast Corner of S. Avenue 8-½ E and E. 40th Street (rezone 19.3 acres of property from the Agriculture District to the Low Density Residential District) (ZONE-28098-2019) (DCD)

Knight asked if the 50-foot half width on 40th Street would be sufficient to include a bicycle lane.

Simonton responded that it would be sufficient to accommodate a bicycle lane or multi-use path as stated in the City's Bicycle Facilities Master Plan.

Ordinance O2020-006 – Rezoning of Property: North of the Intersection of E. 8th Street and S. Castle Dome Avenue (rezone approximately 14.9 acres of property from the General Commercial District to the High Density Residential District) (DCD)

Kerry Schimpf of Commercial Properties Group explained that this rezoning encompasses almost 15 acres of the 25-acre, seven lot subdivision that makes up this project, which will consist of a 100-103 room extended stay and select service hotel. Currently infrastructure extension is being completed, and in the coming months Castle Dome Avenue will be extended into the project as required by the redevelopment agreement with the City. **Schimpf** thanked the City for being a great partner in this project.

Ordinance O2020-006

An ordinance of the City Council of the City of Yuma, Arizona, amending Chapter 154 of the Yuma City Code, rezoning certain property located in the General Commercial (B-2) District to the High Density Residential (R-3) District, and amending the zoning map to conform with the rezoning (approximately 14.9 acres of property located north of the intersection of E. 8th Street and S. Castle Dome Avenue) (DCD)

Resolution R2020-002 – General Plan Amendment: Susan Lee Battaile Trust (change the land use designation from Medium Density Residential to Commercial for the property located at 7600 E. 32nd Street) (DCD)

Deputy Mayor Watts opened the Public Hearing at 5:50 p.m.

Albers presented the following information:

- This request is to change the land use designation for approximately 2.82 acres located on 32nd Street west of the A Canal.
- The intent of the applicant is to rezone the property from Agricultural to General Commercial in order to continue the recreational vehicle sales operation that has historically operated at this site.
- City staff has received no public comments on this request.
- On January 27, 2020, the Planning and Zoning Commission recommended approval of the request.

Motion (Knight/Morris): To adopt Resolution R2020-002 as recommended.

A resolution of the City Council of the City of Yuma, Arizona, amending Resolution R2012-29, the City of Yuma 2012 General Plan, to change the land use designation from Medium Density Residential to Commercial for the property located at 7600 E. 32nd Street (approximately 2.82 acres of property) (DCD)


Elisabeth Haskell, City resident, expressed concern regarding efforts to declare Yuma a Second Amendment sanctuary city due to increasing gun violence in America.
