CALL TO ORDER

Mayor Nicholls called the City Council meeting to order at 5:30 p.m.

INVOCATION/PLEDGE

Deacon David Clark, Immaculate Conception Church, gave the invocation. **Rhonda Lee-James**, Assistant Director of DCD/Neighborhood Services, led the City Council in the Pledge of Allegiance.

FINAL CALL

Mayor Nicholls made a final call for the submission of Speaker Request Forms for agenda related items from members of the audience.

PRESENTATIONS

Life Saving Award Recognition

Irr recognized City employee Jason Brown, who during his recycling collection route encountered an unresponsive 79-year-old man. Irr explained that Brown called 911 and administered compression-only CPR until paramedics arrived. Thanks to Brown's actions, the man survived and is now back home. Irr presented Brown with the Life Saving Award from the Yuma Fire Department as well as the Chief's Coin and Fire Department Coin.

Yuma County Public Health Services District Update

Diana Gomez, Yuma County Public Health Services District (Health Department) Chief Health Officer, provided the following update regarding COVID-19 in Yuma:

- Yuma's Numbers To Date
 - o 54,650 total tests
 - o 11,319 cases
 - o 275 deaths

- Current COVID-19 Hospitalizations
 - 58 total hospitalized at Yuma Regional Medical Center
 - o 18 patients in the Intensive Care Unit
 - The majority of those infected with COVID-19 will have mild to moderate symptoms; when the percentage of people that require hospitalization decreases, it is a sign that the mitigation strategies such as face coverings and social distancing are working
- Personal Protective Equipment (PPE) Distribution
 - o The Health Department is the largest provider of PPE for clinical healthcare providers and those who are conducting testing
 - o PPE can be requested from the Health Department via a Resource Request Form; the supply chain has so far allowed for those requests to be filled in a timely fashion
- COVID-19 Testing
 - The Regional Center for Border Health and Sunset Community Health Center both offer daily drive-through testing during flexible hours
 - o There have been delays in some cases of up to 14 days for test results
 - Quest Laboratories announced yesterday that they have cleared their backlog
- · Contact Tracing
 - o The Health Department has entered into an agreement with the University of Arizona to increase contract tracing efforts by utilizing medical and public health students
 - o Getting test results back within the two to three day reporting cycle is critical for effective contact tracing given the recommended 10-day isolation period
- · Back to School
 - o The Arizona Department of Health Services (ADHS) will release a set of standards tomorrow that schools can use to determine if and when they can reopen safely
 - The Health Department will support schools by reviewing their preparedness and communication plans and providing kits including non-contact thermometers, face masks, and sanitation equipment

Discussion

- If a person is tested multiple times, each test is counted toward the cumulative total number of tests taken; if that person has multiple positive test results, those results are consolidated and only counted as one positive (Knight/Gomez)
- Statistics regarding recovered patients are not reported because recovery can look different for each patient; some taking weeks or months to fully recover, so there is no way to accurately capture that information (Knight/Gomez)
- Communities that are reporting the number of recovered patients are generally applying the 10-14 day metric to any patients who have not passed away, which does not necessarily reflect the actual number of patients who have fully recovered (Mayor Nicholls/Gomez)
- Public health and medical students are bound by the Health Insurance Portability and Accountability Act (HIPAA), so those that will be serving as a contact tracer for the Health Department are required to adhere to HIPAA requirements (**Knight/Gomez**)
- First responders, along with other healthcare providers, can now access information regarding COVID-19 patients pursuant to an Executive Order issued by Governor Ducev (Knight/Gomez)
- While doctors throughout the country may be providing a variety of opinions on COVID-19, the Health Department works closely with ADHS and follows the guidance of the Centers for Disease Control and Prevention (CDC) (Shoop/Gomez)

- ADHS has established a workgroup that meets weekly to discuss statewide guidelines for school reopening; because the situation in each county may differ, the approach to reopening will be tailored to each specific county and school district (Shoop/Gomez)
- The Health Department works with local law enforcement to ensure they have PPE and asks that anyone participating in protests wear face coverings and adhere to the guidelines set forth by the CDC (Shoop/Gomez)
- Test accuracy varies by testing mechanism, with the standard PCR (Polymerase Chain Reaction) test being the most accurate; testing turnaround time should begin to decrease now that the backlog issue with Quest Diagnostics has been resolved (Watts/Gomez)
- Family gatherings and other large get-togethers have been a major source of the spreading of COVID-19, based on information gathered by contact tracers (Watts/Gomez)
- Understanding of symptoms and long-term health impacts is still developing as COVID-19 is a novel virus; this along with the prevalence of asymptomatic patients makes it especially important to follow the suggested mitigation efforts such as face coverings and social distancing (Watts/Gomez)
- The positive cases reported by the Health Department are only those that have been lab-confirmed by an antibody or PCR test, not presumptive cases based on symptoms alone (Morris/Gomez)
- While there is always the possibility of an occasional case slipping through, duplicate positive results are merged by the system used to track testing; the Health Department provides a second review to detect any that the system may have missed (Morris/Gomez)
- Cause of death is determined by the treating physician and/or the medical examiner; the Health Department does not make the determination of cause of death (Morris/Gomez)

Fiscal Year 2020 Financial Briefing

Rodriguez presented the Fiscal Year (FY) 2020 Financial Briefing as follows:

- The fourth quarter (Q4) saw a three-month revenue decline of at least \$1.4 million across major revenue sources due to COVID-19 and related economic volatility
- The first three months of FY 2020 saw better than projected revenues which allowed FY 2020 to end stronger than had been projected

Discussion

- Everything is in and final with respect to the City's receipt of state and local sales tax; the City had a very strong quarter which led to the local sales tax revenues being very healthy compared to state sales tax revenues (Mayor Nicholls/Marlin)
- City staff will look into whether the state sales tax revenue is typical for Q4 or of it is an anomaly based upon COVID-19's impact on the economy (Mayor Nicholls/Marlin)
- Most of the funds reporting greater expenditures than revenues have either built up a fund balance in anticipation of a project or are capital projects paid for by prior bond sales (Shoop/Marlin)
- Some of the Capital Improvement Program (CIP) projects are dependent on grant funding that has not been awarded at this time, so those projects will not begin unless and until the funding is received (Shoop/Rodriguez)

- Employee pay increases are still included in the budget; the Frontline Focus Group will begin meeting next week to review revenues and expenditures to provide a recommendation as to when those increases should take place (Shoop/Rodriguez)
- There have been concerns that the ongoing pandemic may reduce the number of winter visitors coming to Yuma in the fall; while the impact to the City's revenues remains to be seen, Yuma's public health data has started to take a turn for the better which is encouraging (Shelton/Rodriguez)
- There have been discussions at the state level on implementing a program to get the message out to winter visitors regarding Arizona's improving public health data in order to help the state as a whole (Mayor Nicholls)
- A potential loss had been built into the budget for Q4 across almost every fund; fortunately the actual revenues were better than projected, with some funds actually coming in positive where losses had been expected (Morris/Rodriguez)

I. MOTION CONSENT AGENDA

Motion Consent Agenda Item B.5 – City of Yuma Small Business Relief Grants – Additional Allocation of Funds (increase the original funding by \$230,000 for a total allocation of \$550,000) (Admin)

Rodriguez explained that the City has partnered with the Arizona Community Foundation of Yuma to receive and process the applications for the small business relief grants as well as to award the funds. As of this morning, almost the entire initial funded amount of \$320,000 has been awarded to local businesses and more than 30 applications remain pending. The additional allocation of \$230,000 would allow the program to continue to help as many small businesses as possible. Knight noted that the City is paying a very reasonable fee of 1.9% to the Arizona Community foundation to administer the program and disburse the grant funds and suggested that it would be appropriate to increase the allocation of funds by an additional \$10,450 to cover the third-party administration fee.

Motion (Knight/McClendon): To increase the allocation of funds to the City of Yuma Small Business Relief Grants by an additional \$10,450 for a total additional allocation of \$240,450, so that the entire \$550,000 is available for local eligible businesses. Voice vote: **approved** 7-0.

Motion (Knight/McClendon): To approve the Motion Consent Agenda as amended. Voice vote: **approved** 7-0.

Appointments

Motion (Shoop/Watts): To appoint Sonia M. Ramirez Sardinas as Hearing Officer for the City of Yuma.

Mayor Nicholls asked if there was a term expiration date for the appointment. Files replied that the Hearing Officer appointments remain until the appointee resigns or City Council removes them from the position.

- Household Hazardous Waste drop-off is available by appointment on the second Friday of each month from 6:00 a.m. to 8:00 a.m. Residents can contact Public Works to schedule an appointment.

VI. CALL TO THE PUBLIC

Aaron Bellisle, City resident, expressed concern regarding the large feral cat colony in his neighborhood and the lack of response from Animal Control and the Humane Society to calls for assistance with the cats.

Gary Wright, City resident, spoke in opposition of the proposed Yuma City Charter (Charter) amendment that would change the City's elections to even-numbered years. Files interjected that there is a prohibition on using City resources to advocate for the support or opposition of any ballot measure. Mayor Nicholls explained that Call to the Public cannot be used as a forum to argue for or against the Charter amendment now that it is on the ballot for the upcoming General Election.
