Luis Cardenas Camacho, Partnership Specialist assigned to Arizona Government presented as follows:

2020 Census: Measuring Response Rates

- National Self-Response Rate: 67%
- Projected Self-Response Rate: 65.6%
- Response Rate in 2010: 66.5%

First Nationwide Census Available Online

- No down time
- No data breaches
- Average Response Time: 9 minutes

How did people respond?


- Internet (easiest and preferred): 79.86%

- Use of Administrative Records: 13.9% (22.5% projected)

**Cardenas Camacho** stated a percentage of the Census information was also gathered through IRS and Social Security records; as well as neighbors corroborating for those who did not participate in filling out the Census form.

# Fireworks in Arizona

# Deputy City Attorney Rodney Short and Fire Marshall Kayla Franklin presented as follows:

Fireworks

- Fireworks are a state law under Arizona Revised Statutes A.R.S. § 36-1601 et seq.
- Pursuant to state statues, the use of consumer fireworks are permissible during the Cinco de Mayo, Independence Day, Christmas and New Year holidays in Arizona
- Any fireworks that leave the ground or explode are illegal to use or sell

Permissible Locations for Consumer Fireworks

- Only allowed on private property (i.e. your front or back yard) and the firework display cannot extend from your front or backyard to sidewalks, roads, or neighboring properties.
- Consumer fireworks are not allowed on any public property: this includes sidewalks, streets, schools, parking lots, etc.
- It is against the law to use illegal fireworks in any location public or private

# Enforcement

- The state limits local authority's enforcement
- Depending on facts and evidence, civil charges or criminal charges may be imposed with fines or penalties
- Law imposes financial responsibility for users who cause property damage or physical injury and financial responsibility for all costs of fire suppression
- Existing law also sets up 'private causes of action' which is a lesser standard of proof, evidence, and remedies could include offenders homeowner's insurance
- Need to engage State Legislators, often relays by local city officials do not have the same urgency at the state Capitol
- Statewide issue with Arizona Office of Courts for penalties, but Yuma has found local solution
  - Local authority could adopt additional restrictions around the use in or around areas surrounding a municipal or county preserve, desert park, regional park, designated conservation area, national forest or wilderness area (still have enforcement preemption)

What can be done to help?

- If you see fireworks being used illegally, please call the Yuma Police Department at (928) 783-4421 (non-emergency number) and in the case of emergency (including fires and injuries) call 911.
  - Local calls are a simply a first step citizens need to contact the state legislators
- The City of Yuma encourages residents to be good neighbors
  - Be considerate of the times you are using permissible consumer fireworks
  - Cease using illegal fireworks.

Franklin presented statistics on fireworks incidents as follows:

- There are over 19,000 fires and over 9000 injuries resulting from the use of fireworks annually in the country.
- Fire Departments do not advocate for permissible consumer fireworks, as they are also dangerous, especially when given to children to hold.
- Because the state allows certain fireworks, it certainly does not mean that they are safe.
- Fireworks such as sky rockets or missile type rockets that have some sort of explosive do require a federal permit and also a background clearance and certification to transport and operate that type of firework.

Short added the following:

- In the year 2020, Yuma Police Department responded to 132 fireworks calls during Independence Day, 112 fireworks calls during Christmas and 108 fireworks calls during New Years.
- Yuma Police Department and the Yuma Fire Department work diligently to keep the community safe by attending to the emergency calls related to fireworks.
- When a report from a citizen comes in, it is very difficult to determine who launched the firework, thus making it hard on the investigative party to start a criminal process and catch the perpetrator.
- The law favors civil tickets; however, depending on the facts of evidence there can be criminal charges.
  - o Legislature has taken away most of the criminal penalties
- The law heard the third party's personal liability and invoked actually strict liability for any fires or any damages caused by fireworks.
- Contact your State Legislators if you would like to see any changes to the law regarding fireworks.

# Discussion

- Concern was expressed over the fireworks that went off during the New Year's holiday. Stating that the loud bangs not only affect people who deal with Post Traumatic Stress Disorder, but also pets and neighboring homes. (Shelton)
- Although there are dates specific to the use of consumer fireworks, there is no set hours when fireworks may be used. (Knight/Short)
- The Yuma Fire Department issues permits for the sale or storage of permissible consumer fireworks within City of Yuma's jurisdiction, for only \$10. Permit holders provide YFD their bill of sale on the products, as a measure to match the types of fireworks, permitted for sale within the City of Yuma's jurisdiction. (Franklin)
- Enforcement is a big issue and bringing forth criminal charges is difficult; illegal firework use is a statewide issue. (Short/Knight)
- Residents are encouraged to contact their State Legislators to get the ball rolling for tougher laws. (McClendon / Short)
