#### PRESENTATION

# Arizona Public Service Summer Preparedness

**Regina Twomey**, Public Affairs Manager with Arizona Public Service (APS), presented the following information regarding APS' summer preparedness efforts:

- APS Service Territory
  - Serves 11 out of Arizona's 15 rural counties with nearly 34,646 square miles of service territory
  - Nearly 500 substations, roughly 300,000 transformers, and more than 550,000 poles and structures
- Clean Energy Commitment
  - o In January 2020, APS set a Clean Energy Commitment with a goal to provide 100% clean, carbon free electricity to customers by 2050
  - o 2030 target 65% clean energy with 45% renewable energy
  - o End coal-fired generation by 2031, which is seven years sooner than originally anticipated
- Project Update
  - Orchard Substation South Avenue 5½ E & East County 14<sup>th</sup> Street scheduled in service 12/2021
  - o Pacific Substation near the Yuma Palms Mall scheduled in service 12/2022
    - Will replace a temporary substation currently in use
  - o Battery Storage Foothills, Hyder I & II scheduled in service 4/2022


Will increase reliability and allow APS to better serve Yuma County customers

## • Summer Preparedness

- o Generation resources and transmission capacity in place to meet customer load and reserve requirements
- o Infrastructure improvements on schedule to meet summer 2021 power needs
- o Maintenance efforts are on track for completion
- o Coordination with external emergency management agencies
- o Internal emergency preparedness plans & training
- o Customer focused updates to website (aps.com) outage map, 24/7 Customer Care Center, increased efforts to shorten planned outages, etc.

## • 2020 Recap


- o Arizona experienced the hottest summer on record
  - 53 days above 110 degrees
  - 14 days above 115 degrees
- o APS set an all-time peak of 7861 megawatts on July 30 at 5:34 p.m.; the high temperature was 118 degrees
- o Customer response and partnerships were essential
- o Focus on resource planning, sufficient reserve margins, fire mitigation, and overall preparedness were key to maintaining reliability
- 2021 Peak Resource and Demand




## Fuel Supply for Generating Facilities

- o Palo Verde
  - Nation's largest source of clean-air energy
  - Supplies 70% of Arizona's clean-air energy
  - 100% of fuel requirements are contracted through 2026
  - Overall station capacity factor was 91.24% in 2020

- Natural Gas Supply & Transport
  - o Primary firm gas transportation contracts on three interstate gas pipelines: El Paso, Transwestern and North Baja
  - o Access to San Juan (northwest New Mexico) and Permian (west Texas) gas supply basins
  - o APS has a healthy margin for natural gas and traditional energy; if access is lost to one fuel source, other options are available
  - o APS is part of the Western Energy Imbalance Market which means that it shares power with and receives support from California, Washington, Nevada, and Oregon
  - o APS does not ever anticipate or plan rotating outages, but may ask customers to conserve energy during the summer months by adjusting their thermostats up and turning off lights or fans when not in a room





- Emergency Management
  - o Disaster recovery exercises and tabletop emergency preparedness plans help APS predict and practice for emergency events
  - o Mutual assistance and coordination with neighboring utilities (Salt River Project and Tucson Electric Power)
  - o Fire and emergency management coordination with various federal, state and local agencies
  - o Electric Load Curtailment Plan
  - o Emergency Response and Disaster Recovery Plans
- Customer Centric Outage Planning & Response
  - o Improved Outage Map and aps.com resources
    - Enhanced navigation and weather overlay
    - Detailed information for up to four hours after an outage is restored
  - o Text alerts and increased communications
    - Updating bills to make them easier to read
    - Giving updates before, during, and after an outage
  - o Ice reimbursements for extended outages
  - o 24/7 Customer Care Center
    - Customers can reach a live representative any time of day
  - o Continued response to COVID-19

- The APS Promise
  - We do what is right for the people and prosperity of our state
  - o We will create a sustainable energy future for Arizona
  - o We will serve clean, reliable and affordable electricity to our customers and communities

#### Discussion

- If there is an extended outage classified as anything over four hours and a customer need to purchase ice to keep food or medication cold, they can submit their receipts to APS Customer Service for reimbursement (Shelton/Twomey)
- APS does not disconnect electricity when weather is above a certain temperature, or below a certain temperature in northern Arizona. (Nicholls/ Twomey)
- The program that halted disconnections during the COVID-19 pandemic has ended (Nicholls/Twomey)
- The Pacific Substation project will replace a temporary substation, moving it to be contained within the walls built several years ago and upgrading the two transformers from two 120 Mega Volt Amp (MVA) transformers to two 220 MVA transformers (**Knight/Twomey**)

Motion (Knight/Watts): To adopt the Ordinances Consent Agenda as recommended.

### Ordinance O2021-010

An ordinance of the City Council of the City of Yuma, Arizona, authorizing the grant of a utility easement on City-owned real property, hereafter described, to Southwest Gas Corporation, for the reason that such easement is required for the continued operation and maintenance of an existing natural gas line located in Block 14, City of Yuma (replaces an existing undefined easement with a new easement located from Madison Avenue to Main Street between 2<sup>nd</sup> and 3<sup>rd</sup> Streets) (Eng)

Roll call vote: adopted 6-0-1, Mayor Nicholls abstaining due to conflict of interest.

### III. BUDGET AND RELATED ITEMS

There being no speakers, **Bushong** displayed the following title:

#### Resolution R2021-011

A resolution of the City Council of the City of Yuma, Arizona, adopting the Fiscal Year 2022 through Fiscal Year 2026 Capital Improvement Program (in accordance with the Yuma City Charter, Article XII, Section 11) (Eng)

Roll call vote: adopted 6-0-1, Mayor Nicholls abstaining due to conflict of interest.

### Speaker

• Gary Wright, City resident, commented on the Fiscal Year 2022 Proposed Budget, noting that he would like to see an increase to the salaries of the City's public safety personnel and elimination of the entrance fee at the Pacific Avenue Athletic Complex.

**Motion** (Morris/Watts): To approve the Fiscal Year 2022 Proposed Budget for the Capital Improvement Program in the amount of \$158,300,018. Voice vote: **approved** 6-0-1, Mayor Nicholls abstaining due to conflict of interest.

Mayor Nicholls returned to the dais.

**Deputy Mayor McClendon** declared a conflict of interest with regard to the portion of the budget pertaining to Visit Yuma and left the dais.

Motion (Knight/Morris): To approve the Fiscal Year 2022 Proposed Budget for Visit Yuma in the amount of \$600,000. Voice vote: approved 6-0-1, Deputy Mayor McClendon abstaining due to conflict of interest.

Deputy Mayor McClendon returned to the dais.

**Motion** (Knight/Watts): To approve the Fiscal Year 2022 Proposed budget for an amount of \$363,577,284 which excludes the Visit Yuma and Capital Improvement Program that were approved through the prior motions. Voice vote: **approved** 7-0.
