CALL TO ORDER

Deputy Mayor McClendon called the City Council meeting to order at 5:43 p.m.

INVOCATION/PLEDGE

FINAL CALL

Deputy Mayor McClendon made a final call for the submission of Speaker Request Forms for agenda related items from members of the audience.

PRESENTATIONS

Reading of National Purple Heart Day Proclamation

Mayor Nicholls read a proclamation declaring August 7, 2021, National Purple Heart Day. Mayor Nicholls encouraged the citizens of Yuma to show their appreciation for the sacrifices the Purple Heart recipients have made in defending our freedoms, to acknowledge their courage, and to show them the honor and support they have earned.

Marine Corps Air Station (MCAS)-Yuma Weapons and Tactics Instructor (WTI) Exercise Col. Dudik and Col. Gillette presented a video for WTI 2-21; both thanked City Council and the community for the ongoing support.

Capt.Olsen, WTI Coordinator presented the following:

AST-3 Overview

- October 8th 2021 WTI students will conduct the following exercises simultaneously:
 - o Non-Combatant Evacuation Operation (NEO) in Twentynine Palms, CA
 - o Foreign Humanitarian Assistance (FHA) in Yuma
- The purpose is to provide WTI students with realistic training in conjunction with external government agencies that is consistent with a contingency mission they may execute in real-world operations.
 - o The flight window will be from 4:00p.m.to 10:00p.m. on October 8th

- o Yuma landing sites include:
 - Kiwanis Park
 - Crane Middle School
 - Yuma Regional Medical Center
 - Aux IV/Rolle
 - Arizona Western College

Safety Environment

- Aviation Safety: No ordnance will be carried on any aircraft/personnel and strict adherence to FAA Regulations
- Ground Safety: Site Commanders and Firefighting teams will be on-site at each zone to ensure the safety of all participants
- Environment: There will be minimal vehicle movement as to not damage the parks

Spectators

- Spectators are encouraged to attend event and asked to follow instructions and/or directions of local authorities and exercise personnel, for their own safety
- Role players will be in civilian clothes and wearing reflective belts


Capt. Olsen thanked City Council for their time and support.

Investment Strategy Update

Rodriguez introduced Linda Patterson, President, and Jason Headings, Senior Vice President, of Patterson & Associates, one of the City's investment management teams. **Patterson** presented on the City's investment portfolio as follows:

Patterson stated that this slide provides an overview of what is affecting the portfolio.


Federal Reserve Outlook:



- Change in real Gross Domestic Product (GDP):
 - The gross domestic product for the U.S. looks daunting; it looks like we are going backwards.
 - o The Federal Reserve sees the GDP returning to normal after coming out of COVID
- Unemployment rate
 - o The Federal Reserve watches inflation and unemployment
 - It is anticipated that the unemployment rate is going to stay where their target is, which is full employment for the United States
- Core Personal Consumption Expenditure (PCE) Inflation:
 - o There is a great deal of uncertainty in the marketplace
 - o There are three major things happening:
 - Federal Reserve
 - Keeping interest rates low for mortgages and business loans in an effort to get the economy started
 - COVID
 - The new Delta variant is creating questions such as what is going to happen; will businesses have to close again
 - Inflation
 - Is this a permanent situation or is this something that is transitory
 - o The Federal Reserve is saying that inflation is transitory right now, not permanent
- Federal Funds Rate
 - o The overnight rate that is holding liquid money down
 - o Once the uncertainty of COVID is resolved, interest rates will rise again.
 - o It is a great time to go out for bonds on the debt side; to use the low rates to issue debt or take out loans
 - o It does hurt on the portfolio side; less interest earned

Historical Yields


LGIP rates remain anchored to Fed policy



- The green line shows money that is not invested but left totally liquid; money market fund equivalents
- Extending part of the portfolio to the blue earned a little more in the 2 year Treasury
- Extending even further to the 4-5 year Treasury earned roughly \$300,000 in interest over the past six months.
- Currently working with staff and the administrator to come up with a strategy that serves the City as best as possible

Current Total Portfolio

City of Yuma portfolio as of 06/30/2021



Current portfolio assets invested in securities amounts to \$63 million

- Weighted average maturity is 2.8 years; meaning the investments will be totally liquid in 2.8 years.
- The weighted average yield on the portfolio is 0.50%
- Patterson & Associates job is to help the City find the value available and to move those securities to increase the average earnings

Discussion

- This investment portfolio does not show up in the budget but rather in the annual financial report or CAFR. One of the goals is to have it correspond with the quarterly financial updates on revenues and expenditures in the format similar to the "historical yields" slide showing where those assets are sitting. (Mayor Nicholls/Rodriguez)
- The "Your Asset Allocation" shown in the above slide shows funds that are tied to operating funds, CIP funds, general funds, debt service etc. The "Your Maturity Distribution" graph shows how those funds are spread out over the years. 20% is kept totally liquid so the City would never be in a position where they could not meet a payroll or payables as they come up. (Mayor Nicholls/Rodriguez/Patterson)
- Updating the City's investment policy will be discussed at the upcoming vision and goal-setting meeting.
- The City's portfolio takes into account the City's main objective of safety of the funds because they are public funds. The portfolio is made up of the very highest credit quality funds including the two major agencies Fannie Mae and Freddy Mac, which are full faith and credit of the United States Government. (Shelton/Patterson)
- Many variables come in to play in the decisions the Federal Reserve has to make when anticipating where the rates will go. (Morris/Patterson)
- Inflation rates are a set basket of goods that does not change over time. It takes years for the makeup of that basket to change. (Mayor Nicholls/Patterson)

An ordinance of the City Council of the City of Yuma, Arizona, amending Chapter 154 of the Yuma City Code, rezoning certain property located in the Light Industrial (L-I) District to the Medium Density Residential (R-2) District, and amending the zoning map to conform with the rezoning (approximately 3.13 acres located at the northwest corner of Avenue A and 11th Street) (PNS)

Roll call vote: adopted 6-0-1. (Mayor Nicholls declared Conflict of Interest)

Mayor Nicholls returned to the dais.

An ordinance of the City Council of the City of Yuma, Arizona, accepting an easement over the described real property and authorizing and directing the execution of all necessary documents for transfer thereof (for the purpose of a dedicated pickup/drop-off lane and a multiuse pathway being constructed as part of a roadway improvement project along the west side of Avenue 10E south of 28th St.) (Eng)

An ordinance of the City Council of the City of Yuma, Arizona, amending Chapter 154 of the Yuma City Code, rezoning certain property located in the Low Density Residential/Infill Overlay (R-1-6/IO) District to the General Commercial/Infill Overlay (B-2/IO) District and amending the zoning map to conform with the rezoning (approximately 8,364 sq. ft. for the property located at 1639 S. 6th Avenue) (P&NS)
