**Bid Award: Ready Mix Concrete, Color and Stamp Mix** 

#### SUMMARY RECOMMENDATION:

Award to the sole bidder, BLT Companies, LLLP, Yuma, Arizona, the as-needed purchase and delivery of Ready-Mix Concrete, Color and Stamp Mix, a one-year contract with the option to renew for four additional one-year periods, at an estimated first-year cost of \$63,700.00, which will exceed \$100,000.00 over the five-year life of the contract, depending on the appropriation of funds and satisfactory performance. #### STRATEGIC OUTCOME:

The award of this contract will provide City staff the necessary materials to conduct operations of concrete repairs for maintaining the City's infrastructure, which aligns with the City Council's strategic outcomes of Respected and Responsible and Active and Appealing for use in public spaces.

### **REPORT:**

This contract is for the purchase of Ready-Mix Concrete, Color and Stamp Mix to be delivered on an asneeded basis for use by Parks and Recreation and the Public Works Departments.

The solicitation was rebid as a Request for Qualification with the intent to pre-qualify vendors for Ready-Mix Concrete and provide updated pricing for six months based upon fluctuating material cost, and current market trends.

Only one vendor responded to the solicitation.
