Discussion

Multiple outreach and required steps were completed through public meetings to ensure the
proposed changes do not affect industrial users. There will be no cost or level of effort required for
the City's municipal users. The modification to the limits that are associated with industrial
discharges will not affect the estimated 19 permitted industrial users. The modification is a very
slight increase to two parameters. The modification is needed due to a new discharge permit issued
from the state to the City. (Shelton/McCall)
